



INVITATION FOR BIDS

MUNICIPAL COMMITTEE GOJRA

(Provision of Equipment and Machinery for improvement of Solid Waste Management System in Gojra City.)

- The Government of Pakistan has received a loan (Credit No. 6243-PK) from the International Development Association (IDA) for funding of Punjab Cities Program (PCP) and intends to use part of the funds to cover cligible payments under the contract for sub-project "Provision of Equipment and Machinery for improvement of Solid Waste Management System in Gojra City." The Program will be implemented under the control of Punjab Municipal Development Fund Company (PMDFC).

- 4. The Bidder must
- (i) Be a registered body duly recognizable under the law of Pakistan
- (ii) Be registered with FBR for income Tax and Sales Tax.
- (iii) Not be blacklisted.
- (iv) Not be involved in litigation with any Government Department, Agency/Organization etc.
- (v) Have sufficient financial, technical, and human resources to complete the procurement within the prescribed time limit on the finalization of contract.
- 5. Bidding Documents will be available immediately after publication of this notice and can be purchased from the Office of Chief Officer, Municipal Committee Gojra for a nonrefundable fee of Rs. 10000 for each set. Interested bidders may obtain further information from the same address.
- 6 Bids shall be valid for a period of 90-days after Bid opening and must be accompanied by bid security of 05% of quoted amount in the form of a Bank Draft or an irrevocable cashable on-demand Bank Call Deposit in favor of Chief Officer Municipal Committee Gojra and shall be delivered on or before 10-01-2023 at 12:30 pm. The bids shall be opened in the presence of the bidders or their authorized representatives who choose to attend at 01:00 pm on the same day at the above given office.
- A pre-bid meeting with contractors will be held on 05-01-2023 in the office of Chief Officer, Municipal Committee Gojra and interested bidders are invited for participation.
- 8. Last date of collecting the bidding documents is 09-01-2023
- The Bidding Procedure will be governed by Rule 38(2)a of PPRA, 2014 "Single Stage
 Two Envelopes" procedure. The bids shall be evaluated based on qualification criteria
 provided in the bidding documents.
