CONCLUSION/ DECISION REGARDING FINALIZATION OF SECTOR WISE PRIORITY LIST IN CONSULTATIVE SESSION HELD ON 16<sup>TH</sup> APRIL 2022 IN UNIT GOJRA.

A consultative session was held on 16th april 2022 in Unit Gojra to finalize the sector wise priority list for city Gojra under the chairmanship of Chif Officer Unit Gojra. In the consultative session the participants were Unit Gojra Officers, MMP Consultant Officer. PMDFC DPO (ENV) & DPO (ID), representative from PHED, representative from local parliamentarians, representative from NGO's, president Traders unions, media representatives, Ex- Councilors, everyone floated his suggestion regarding finalization of priority list (MOM attached).

The most pointed out problems of city Gojra were "Water Supply and sewerage system" due to which the public is facing too much hardship like contaminated water in old water supply pipe lines, chocked and over aged sewer lines. Representator of PMDFC suggested that Unit Gojra should install water meter after providing water supply schemes. After this some people identified that Roads of city Gojra need to be improved and maintained as the condition of city roads are getting worst day by day. Media persons were pointed out that parks in Gojra city need improvement and special facilities should be provided for families. Special arrangements should be made which can attract families in the public parks. Ex councilors were identified that More street lights are required in Muhallahas and other unserved areas although LED 120 & 27 Watt Street Lights were installed on main roads and some posh areas under Punjab cities program phase I but many muhllahas and streets needed the street lights and they notified that Solid waste management is the key issue of the city Gojra.

After all the discussion in the consultative session and keeping in mind the problems being faced by general public in city Gojra a conclusion was drawn for finalization of priority list is listed below.

Waleed Usman Chief Officer (Gojra)	<ul> <li>CO (Unit Gojra) has given the introductory remarks and explain the purpose of the meeting being held under his chairmanship.</li> <li>An introduction regarding Punjab Cities Program and Scope of work being included in this program was given by Chief Officer.</li> </ul>

MO(I&S) Gojra	<ul> <li>MOI has discussed about the Punjab cities Program role for the development of Gojra city and role of municipal committee to execute the project</li> <li>MOI has also discussed the past M&amp;R project details which is included in phase 1 of PCP and the targets applicated in this phase 1</li> </ul>

Mudassir Ashraf DPO(ID) PMDFC	<ul> <li>Given the overview of the PCP project, the goals and targets set in the project and how PMDFC is playing its role as technical arm to execute the project</li> <li>Explained the roles of consultants to the audience and the difference between the short-term consultants and long-term consultants.</li> <li>Explained the sectoral planning and the sectors included in this planning e.g sewerage, water supply. Muhammad Sadiq Journalist Duniya News	<ul> <li>He pointed out that water supply issue need to be addressed in the city as there is worst situation of water supply in the city. People need fresh and portable water in the city as the previous water supply schemes are nonfunctional or mostly reached to their designed age.</li> <li>Water contamination with sewer is being pointed out by him on the location of Hassania colony and Sharif Pura as sewerage water mixing with fresh water in this area.</li> <li>Secondly, he said that sewerage system also need to be restored in the city.</li> </ul>
Tanveer Hussain Journalist (Nawa-i-Waqt)	<ul> <li>He mentioned that sewerage system of the city should be developed and the city required more disposal units as the current number of disposal units are insufficient to meet the requirement.</li> <li>Storm water causes main problems in the city areas especially the Pensra road filled with storm water whenever rain happened so proper drainage works should be provided in the city areas and along the main roads so people should get relief in the rainy season.</li> <li>Roads of city need to be maintained and improved and as the condition of city road are getting worst day by day in some areas after laying sewerage line no restoration work is being done by PHED till now therefore people gets.</li> </ul>

Then she pointed out the problems that city is facing.</li> <li>Firstly, the city needs water supply schemes as the fresh water supply is the dire need of people because of contaminated water disease are being spread in the city</li> <li>Sewerage issued need to be addressed on urgent basis especially from Gali # 2 to 17which is the unserved area of the city and storm water causes very problem to the people of these areas.</li> <li>Sloid waste management issues should be addressed proper number of containers should be placed in city as the number of containers now are less then requirement. And a public awareness campaign should be given to the people of the city with the help of all stakeholders regarding solid waste management because many people put the polythene bags in sewer line which cause the choking of sewer line and drainage work stopped. Storm water causes many problems to the people as even the main road is filled with it due to poor drainage work</li> <li>There is a dire need of solid waste disposal site for city as current dumping point i.e Dijkot dumping point and Mongi road dumping point are about to reach their maximum capacity therefore a new landfill site is the need of time.</li> <li>More street lights are required in Muhallahas and other unserved areas although main roads have street light but many muhllahas and streets needed the street lights.</li> </ul>

DEPUTY COMPAISSION Toba Tek Pingh

Punjab Cities program is in implementing phase of Year 02, consultants are on Board to carry out Sectoral planning of all participating Units. In this regard, zoom meeting held on 25th March 2022 of Chief officer and MO (I&S). Agenda of meeting was to discuss and expedite the process of identification of priority sector and intra priority sub projects. The following main points were concluded to follow for finalization of priority sector.

- Sewerage Subprojects without Wastewater Treatment Plant (WWTP) will not be considered.
- Landfill sites will be designed by the consultant as per program document but will not be funded under PCP.
- WWTP will be designed as per program requirement.
- Storm water drains will be designed subject to cater only storm water.
- Reconstruction or renovation of Unit's buildings are excluded from the list of design.
- Those roads will consider having certificates that next 10 years, sewerage and water supply lines
- Roads/ areas in jurisdiction of another department will be considered under PCP after having

According to World Bank criteria for finalization of Priority Sectors, consultative session with relative stakeholder is compulsory. Therefore, it is decided that within 07 days in all Units consultative sessions should be arranged to settle the priority sector. Intimation of date should be communicated to PMDFC in time so that PMDFC could arrange its team to participate. Identification of relevant stakehólders is given as:
